## Privacy Policy

**Last updated:** October 09, 2024. This privacy statement applies to citizens and permanent legal residents of the European Economic Area and Switzerland.

### 1. Purpose of Processing

The processing of personal data you provide, as well as data derived from navigation on the site [www.gliorsistudio.com](http://www.gliorsistudio.com), is aimed at achieving the following purposes:

- a) allowing access and navigation on the site so that you can use the services offered;
- b) operational, managerial, administrative, and accounting purposes;
- c) marketing activities, commercial information, and promotional activities, including sending newsletters and advertising material.

The data processing carried out for points a) and b) does not require specific consent, as it falls under the exemptions provided for by Article 24, paragraph 1, letter b) of the Code. The data processing carried out for point c) can only be conducted with your explicit consent.

### 2. Cookies

By accessing the site, "cookies" may be sent to your computer. These are packets of information sent by a web server (in this case, by the domain [www.gliorsistudio.com](http://www.gliorsistudio.com)) to the user's Internet browser and automatically stored on the user's personal computer.

To fully utilize the site, it is necessary to configure the browser to accept cookies. We inform you that, by default, most web browsers are set to automatically accept cookies. However, visitors can modify the default settings. Disabling or deleting cookies may limit the use of certain areas of the site. If users wish to decide on a case-by-case basis whether to accept cookies, they can configure their browser to display a warning each time a cookie is saved.

The cookies used on the site are:

- **Persistent cookies:** these remain stored until their expiration on the user's hard drive.
- **Third-party cookies:** generated by other sites to provide content on the site being visited.

### 3. Processing Methods – Security Measures

The processing of your personal data may include, in addition to their collection, their recording, storage, modification, communication, and deletion. The processing may also be carried out with or without the use of electronic tools by personnel specifically appointed by the Company as Data Controllers or Data Processors.

Data will be stored in paper and/or electronic form for the time strictly necessary to achieve the purposes set out in point 1, in compliance with applicable legislation. The Company will take all appropriate measures to ensure the security and confidentiality of the personal data you provide us, in accordance with the provisions of the law, especially those provided for in Annex B of the Code.

#### **4. Communication and Dissemination of Data – Transfer of Data Abroad**

The personal data collected for the purposes indicated in point 1 may be communicated, within their specific competence, to public administrations for institutional functions, banks, entities specialized in the management of information systems and/or payment systems, entities that provide goods and services offered by the Company, and consulting firms.

Personal data will not be disclosed. Within the strictly necessary limits to execute the contractual relationship, your personal data may be communicated to third parties, such as suppliers of products and/or services, located both inside and outside the European Union, who will be appointed as External Data Processors and will process the data in compliance with the security measures required by the law and the instructions provided by the Company, as the Data Controller.

#### **5. Rights of the Data Subject**

Pursuant to Article 7 of the Code, you have the right to:

a) obtain confirmation of the existence or non-existence of personal data concerning you and their communication in an intelligible form;

b) obtain from the Data Controller or the Data Processor:

i) information on the origin of the personal data, the purposes and methods of processing, and the logic applied in case of processing carried out with the help of electronic tools;

ii) information about the identity of the Data Controller and the Data Processor(s), as well as, if applicable, the representative appointed by a foreign entity to process the data in Italy;

iii) information about the entities or categories of entities to whom the data may be communicated or who may become aware of them as appointed representatives in the State, Data Processors, or Appointees;

c) obtain:

i) the updating, rectification, or, when interested, the integration of data;

ii) the deletion, anonymization, or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which they were collected or subsequently processed;

iii) certification that the operations referred to in points (i) and (ii) have been brought to the attention of those to whom the data were communicated or disseminated, except when such fulfillment proves impossible or involves the use of means manifestly disproportionate to the right being protected;

d) oppose, in whole or in part:

i) for legitimate reasons, the processing of personal data concerning you, even if relevant to the purpose of collection;

ii) the processing of personal data concerning you for the purpose of sending advertising materials or direct selling, or for carrying out market research or commercial communication.

The above rights can be exercised directly or through a representative, in the forms provided by Articles 8 and 9 of the Code. To exercise the above rights, you must make a written request by regular mail to the Data Processor, as identified below, or by sending an email to [info@gliorsistudio.com](mailto:info@gliorsistudio.com).
